Please Note: All proxy forms must be returned to the CHHA-NL Office (1081 Topsail Road) no later than two days prior to the date of the AGM, thus, the forms must be returned to the office no later than Monday, September 23, 2024 at 4:30 pm.

In accordance with the CHHA-NL By-laws, the following rules apply with respect to voting by proxy:

Article 6 - Meetings

- 6.8 Every member entitled to vote at a Membership Meeting may, by means of a proxy, appoint a proxy holder, or one or more alternate proxy holders, as his or her nominee to attend and act at a Membership Meeting in the manner, and to the extent as the member is entitled. A proxy shall be in the form prescribed from time to time by the Directors and shall be valid only at the Membership Meeting in respect of which it is given or any adjournment thereof.
- 6.9 A proxy must be deposited with the Chapter no later than forty-eight (48) hours, excluding weekends and holidays, prior to the Membership Meeting or the adjourned Membership Meeting at which the proxy is to be used.
